#### Case Manager for High-Risk Pregnancy (CMHRP) and At-risk Children

The Madison County Health Department (MCHD) seeks a Bachelor of Social Work (BSW) professional to serve as a Care Manager. This role will focus on High-Risk Pregnancy Care Management (CMHRP) and Care Management for At-Risk Children (CMARC). Our Pregnancy Care Management program supports Medicaid-eligible pregnant women who meet specific risk criteria, as well as children who are considered at risk.

#### **DESCRIPTION OF WORK:**

The CMHRP/CMARC care manager provides community-based intensive care management services to expectant, new mothers, and at-risk children.

- This involves collaboration with individuals, groups, families, and community service providers.
- Works in various settings coordinating care needs across the healthcare continuum.
- CMHRP care manager ensures patients receive the most efficient and effective care for their condition, allowing for improved patient outcomes.
- CMHRP care manager understands the care delivery system for patients and communicates with doctors and specialists to ensure services and treatments are delivered on time.
- CMHRP care manager provides evaluation, case management, and referral services to assist in meeting the needs of the clients.

This position will make home visits, community, and OB practice visits. The applicant should be self-driven and able to work with minimal supervision.

#### 1. CARE MANAGEMENT FOR At-Risk CHILDREN (CMARC):

- Review CMARC referrals as they are received to assure that the client is eligible for the program.
- Educate referral sources on the benefits of the CMARC program.
- Collaborate with Child Health Care providers and Prepaid Health Plans.
- Complete and enter VIRTUAL HEALTH the Comprehensive Needs Assessment, Life Skills Progression if needed, and developmental screenings (SWYC).
- Determine the engagement/risk level of care to be provided.
- Develop patient-centered care plans, document key activities, and enter VIRTUAL HEALTH.
- Refer clients to relevant education, oral health, behavioral health, or other needed services.
- Assess and follow up on identified needs related to care management services and the results of the developmental screenings.
- Review and monitor Care Impact reports created for the CMARC program to determine individuals at greatest risk.
- Attending CMARC and VIRTUAL HEALTH training offered by DPH.

- Conduct home visits to the families on your caseload.
- Follow program requirements for CMARC.
- In addition to Madison County employees will be responsible for Medicaid Direct members linked to Haywood County.
- Send and receive referrals for resources through the Unite Us Platform as part of the Healthy Opportunities Pilot.

### Minimum Education and Experience:

Social worker with a bachelor's degree in social work (BSW) or master's degree in social work (MSW).

Bachelor's degree in social work from an appropriately accredited institution.

Resumes will not be accepted without the completed application. Application must include a summary of job duties performed and work experience. "See resume" on application is not acceptable. We will need a copy of transcripts.
