## **MINUTES**

### **CALL TO ORDER**

Chair Wallin called the meeting of the Madison County Board of Elections to order at 3:00 p.m. In attendance were Jerry Wallin, Chair; Dyatt Smathers, Secretary; Brian Ball, Member; Debbie Ponder, Member; Jacob Ray, Director; and one member of the public.

#### Agenda:

Motion (DS, JW) to amend the agenda and agenda items "2024 Second Primary Resolution to count absentee ballots and set Absentee Meeting Schedule" and "2024 Second Primary Early Voting Staff approval." The motion passed unanimously (4-0).

## Minutes Approval:

Motion (DS, BB) to approve March 4, 2024 meeting minutes and March 5, 2024 meeting minutes. The motion passed unanimously (4-0).

## Members Reports:

- Member Ball expressed appreciation to the office staff and poll-workers for well-run primary election.
- Secretary Smathers echoed member Ball's comments and reported to the board that the office staff is addressing concerns the poll-workers had with a specific procedure. Secretary Smathers thanked the board for addressing the need to combine precincts for the upcoming Second Primary.
- Member Ponder echoed previous comments made by board members about the election.
  Member Ponder complimented the office staff on the preparedness for potential personnel issues at the Hot Springs precinct.
- Chair Wallin spoke about this Board of Elections willingness to work together.

## Military (MIL) Ballots:

 Walnut Precinct: Motion (DS, JW) to approve <u>one</u> MIL Absentee Ballot. The motion passed unanimously (4-0).

#### **BALLOT DUPLICATION**

Secretary Smathers marked the ballots while member Ball called the contests for duplication purposes.

#### PREPARATORY STEPS TO SECURE COUNTED BALLOTS

Board members verified the public count of <u>four</u> for the Supplemental Absentee DS200 tabulator and the public count of <u>seventeen</u> for the Provisional DS200 tabulator.

Voted ballots were sealed and secured for storage.

The board closed the DS200 tabulators, and the director imported and uploaded the supplemental and provisional results.

### Other Matters:

Motion (DS, JW) to allow the director to retrieve ballot that was cast twice during early voting and conduct a manual edit to election results. The motion pass unanimously (4-0).

Motion (DS, BB) to approve resolutions to transfer voters to adjacent precincts for the 2024 Second Primary Election only.

Motion (DS, JW) to approve resolutions to relocate polling sites for the 2024 Second Primary Election only. The motion passed unanimously (4-0).

Motion (DS, BB) to approve 2024 Second Primary Resolution to count absentee ballots and set Absentee Meeting Schedule. The motion passed unanimously (4-0).

Motion (BB, DS) to approve the 2024 Second Primary early voting staff list as presented. The motion passed unanimously (4-0).
