The Madison County Board of Commissioners met in regular session on Tuesday, July 21, 2015 at 7:00 p.m. in the Courtroom, Madison County Courthouse, Marshall, NC.

The meeting was called to order at 7:00 p.m.

Upon motion from Commissioner Baker, seconded by Commissioner Rice, the Board voted unanimously to approve the minutes from the June 9, 2015; June 17, 2015; June 22, 2015, and July 06, 2015 meetings.

Upon motion from Commissioner Rice, seconded by Commissioner Gentry, the Board voted unanimously to approve the agenda with the following changes:
