Commissioner Briggs' nomination to appoint Commissioner Baker to serve as Chair failed on a vote of 2 to 3. Voting in the affirmative were Commissioner Baker and Commissioner Briggs. Voting in the negative were Commissioner Brigman, Commissioner Gentry and Commissioner Rice.

Chairman Brigman continued the organizational meeting and opened the floor for nominations for Vice-Chair.

Commissioner Briggs nominated Commissioner Baker to serve as Vice-Chair. Commissioner Gentry nominated Commissioner Rice to serve as Vice-Chair.

Nominations ceased.

Chairman Brigman's nomination to appoint Darlyne Rhinehart to serve as County Clerk passed unanimously.

Attorney Laws reviewed the conditions of Sheriff James E. Harwood's bond with the Board. Upon motion from Commissioner Rice, seconded by Commissioner Gentry the Board voted unanimously to approve the bond.

Chairman Brigman announced the Hot Springs and Marshall Christmas Parades.

Upon motion from Commissioner Rice, seconded by Commissioner Gentry, the Board voted unanimously to adjourn.
